Stash Stock Party Rewards Program Terms and Conditions

Effective as of October, 2nd 2023 (the "Effective Date") for all Personal Portfolio Holders (as defined below)

General Description

The Stash Stock Party Rewards Program (the "Program") is a rewards program offered and administered by Stash Investments LLC ("Stash") and is not offered through any of its affiliates, including but not limited to Stash Capital LLC ("Stash Capital"), whereby Personal Portfolio Holders (as defined below) may earn fractional shares of stock of certain publicly-traded companies and/or exchange-traded funds ("Stock"), as specified below. This Program is subject to these Stash Stock Party Program Terms and Conditions (the "Program Terms"). By choosing to participate in this Program, you are accepting and agreeing to these Program Terms. These Program Terms form an agreement between you and Stash with respect to the Program. You should read these Program Terms carefully.

Eligibility

To be eligible to participate in this Program and receive a Stock reward (as defined below) hereunder, you must be a Personal Portfolio Holder. For purposes of this Program, a "Personal Portfolio" is an individual taxable brokerage account advised by Stash that is in good standing. Each person who has completed the process of opening a Personal Portfolio as of or following the Effective Date will be deemed a "Personal Portfolio Holder" under these Program Terms.

For the avoidance of doubt, in the event, you only complete the designated registration process to receive the Financial Counseling Service (if applicable to you, as such term is defined in your <u>Advisory Agreement</u>) from Stash, or you do not otherwise complete the designated registration process required for opening a Personal Portfolio as of or following the Effective Date you will not be deemed a "Personal Portfolio Holder" hereunder.

Stash reserves the right to determine in its sole discretion whether an account is closed and/or in good standing. An account in good standing for purposes of this Program is an account for which all required account opening documentation has been completed and verified and is not locked, or restricted, or otherwise flagged in any way. If your Personal Portfolio is closed or not in good standing for any reason at any time, you will no longer be deemed a Personal Portfolio Holder and you will not be eligible to receive a Stock reward hereunder.

Redeeming Your Stock Reward

On or after the Effective Date, Stash may at any time in its sole discretion select a designated Party Time (as defined below) to offer a predetermined amount of one or more specific Stocks under this Program. For purposes of these Program Terms, each specific timeframe (as shown

on <u>https://stash.com/party</u>) that Stash determines to offer Stock(s) shall be deemed the "Party Time", and the specific date on which each Party Time falls on shall be deemed a "Party Day". Stash will use reasonable efforts to announce each Party Day and Party Time in advance.

On each Party Day, Stash will offer a predetermined amount of one or more specific Stock(s) at the Party Time to any person that completes either set of eligibility steps outlined below, as applicable to such person, during the time periods also specified below.

<u>Eligibility Set #1</u>: If you are a Personal Portfolio Holder as of the Party Time on a specific Party Day, then you must complete each of the following steps on that given Party Day:

<u>Step 1</u>: you must visit the following unique link: <u>https://stash.com/party</u>

<u>Step 2</u>: you must select the "Log In" icon that appears on the unique link and enter your login credentials (e.g. email and password) attributable to your Personal Portfolio; **AND**

<u>Step 3</u>: you must select the "Claim Stock" icon that will appear on the unique link during the Party Time shown on <u>https://stash.com/party</u> on that given Party Day (*for example, if the Party Time is 8:00 PM (ET) to 9:00 PM (ET) on the Party Date, then you must complete this <u>Step 3</u> between 8:00 PM (ET) and 9:00 PM (ET) on the Party Date).*

<u>Eligibility Set #2</u>: If you are not a Personal Portfolio Holder as of the Party Time on a specific Party Day, then you must complete each of the following steps on that given Party Day:

<u>Step A</u>: you must visit the following unique link: <u>https://stash.com/party</u>

<u>Step B</u>: you must select the "Sign Up For Stash" icon that appears on the unique link and enter a valid email address and password;

<u>Step C</u>: you must select the "Claim Stock" icon that will appear on the unique link during the Party Time shown on <u>https://stash.com/party</u> on that given Party Day (*for example, if the Party Time is 8:00 PM (ET) to 9:00 PM (ET) on the Party Date, then you must complete this <u>Step C</u> between 8:00 PM (ET) and 9:00 PM (ET) on the Party Date).*

<u>Step D</u>: you must then subsequently complete the designated registration process of opening a Personal Portfolio, as required by the interactive instructions displayed via the Stash Platform; **AND**

<u>Step E</u>: after you complete <u>Step D</u>, you will then be eligible to receive the Stock reward.

For the avoidance of doubt, you will not receive a Stock Reward hereunder on a Party Day if you: (i) on that specific Party Day, select the "No Stock for me" icon that appears on the unique link under either <u>Step 3</u> or <u>Step C</u> above, as applicable to you, and you do

not subsequently complete the detailed steps applicable to you in the order outlined above in a timely fashion, or (ii) on that specific Party Day, otherwise fail to complete the detailed steps applicable to you in the order outlined above in a timely fashion. Further and for the avoidance of doubt, if you fall under Eligibility Set #2 above you may complete <u>Steps A, B and C</u> prior to the applicable Party Time by following the interactive instructions available at <u>https://stash.com/party</u>.

Only Personal Portfolio Holders that complete either set of applicable eligibility steps outlined above in a timely fashion on each Party Day (each such Personal Portfolio Holder shall be referred to hereunder as an "Eligible Reward Recipient" for that specific Party Day) will be eligible to receive a Stock reward in an amount equal to the amount of total Stock that Stash is offering on that specific Party Day, as calculated below, divided by the number of Eligible Rewards Recipients on that specific Party Day (each such Stock reward shall be deemed a "Stock Reward"). The number of Eligible Reward Recipients will reset following each Party Day to zero (0), and will not carry over from one Party Day to the next.

Calculating The Amount of Stock That Stash Will Offer On Each Party Day

The total amount of Stock that Stash will offer on each specific Party Day will increase based upon a multiplier that takes into account the amount of participating Eligible Reward Recipients on that particular Party Day. The maximum amount of Stock that will be rewarded will be \$50,753.16, which is based upon a maximum amount of 300,000 Eligible Reward Recipients. If the amount of Eligible Reward Recipients is greater than 300,000, then the amount of Stock will remain at \$50,753.16.

Once Stash determines the total amount of Stock that it will give away on a particular Party Date based on the above, Stash will take that total amount and divide it by the amount of Stock(s) that Stash is giving away on that particular Party Date (each divided amount shall be referred to hereunder as an "Offering Amount"). For example, if on a Party Date Stash is offering Stock of Company A and there are 300,000 Eligible Rewards Recipients on that given Party Day, then Stash will offer Stock Rewards in the aggregate amount of \$50,753.16 of Company A Stock to all Eligible Rewards Recipients on that specific Party Date (for a Stock Reward in Company A Stock of ~\$0.17).

The amount of each Stock Reward offered through the Program shall be limited to a daily maximum cash value of \$5.00 per Eligible Rewards Recipient on each Party Day, which shall be calculated by Stash in its sole discretion. In no event will you be eligible to receive a Stock Reward hereunder in excess of the limit described in the preceding sentence. Further, each Eligible Reward Recipient is only eligible to claim one (1) Stock Reward on each Party Day under this Program. The specific Stock(s) that Stash may offer on each Party Day will be determined by Stash in its sole discretion. Eligible Rewards Participants will be notified on or about two hours following the Party Time of the amount of their specific Stock Reward for that given Party Day.

Crediting Your Stock Reward To Your Personal Portfolio

By accepting an offer to earn a Stock Reward, you are making a decision to invest in that specific underlying Stock and you agree that it is your responsibility to review and carefully consider the Stock, including the information available to you through the Stash mobile applications and website (collectively, the "Stash Platform") about such Stock, before choosing to accept a Stock Reward hereunder. Neither this Program itself, nor the Stock available to be earned through it, is a recommendation to buy any such specific Stock. The value of any Stock Reward you receive may fluctuate over time due to a variety of factors. Please refer to the Stash Platform (<u>www.stash.com/investments/stocks/</u>) for a list of all investments. Stash reserves the right to change the list of investments available on the Stash Platform at any time and from time to time in its sole discretion.

By accepting a Stock Reward hereunder, you are agreeing to initiate a "buy" order for such Stock in the amount of your Stock Reward. To deliver a Stock Reward to your Personal Portfolio, Stash will convert the monetary amount of your Stock Reward into a Stock position based on the reported lowest execution price of the relevant stock from the current business day, and Stash will direct Stash Capital to purchase those shares of Stock in its proprietary account ("Stash Capital Proprietary Account"). Upon the trade settlement date, Stash will instruct Stash Capital to journal the Stock Reward position to your Personal Portfolio through a journal entry. If a Stock Reward transaction completes outside of the trading window to fulfill Stock Rewards (a" Rewards Window)" on the current trading day and before the start of the Rewards Window on the next trading day, the reported lowest execution price of the Stock on the next trading day shall be used.

By accepting an offer to earn a Stock Reward, you are authorizing Stash to direct, and Stash Capital to execute, orders to buy the specific Stock offered to you through a journal entry from the Stash Capital Proprietary Account. Any Stock Reward may take up to four (4) business days to be reflected in your Personal Portfolio. For the avoidance of doubt, you have the ability to decline the offer to earn any Stock Reward and the ability to sell any Stock Reward earned under this Program after you receive it in your Personal Portfolio. For additional information related to your Stock Reward, you may review the transaction details in the portfolio activity section available through the Stash platform ("Platform"). In order to fulfill your Stock Rewards, Stash and Stash Capital have entered into an agreement whereby Stash Capital, an affiliate of Stash (also referred to as "Service Provider"), is paid a service fee ("Service Fee") to purchase and manage Stock inventory in the Stash Capital Proprietary Account.

By participating in this Program, you grant Stash the limited discretionary authority required to complete the securities transaction necessary to complete a Stock Reward. This discretionary authority is in addition to the limited discretionary authority you have already granted to Stash pursuant to your Advisory Agreement, as amended, that you agreed to when you opened your Personal Portfolio. initially accept these terms, and you are hereby notified of such amendment and modification by these terms.
